A list of all the movies and TV shows currently playing at a theater near you..A federal judge has thrown out the bulk of a lawsuit filed by more than 20 state attorneys general against President Donald Trump in order to stop him from ending special protections for young undocumented immigrants who arrived in the country as children. Trump promised during his campaign to end the Obama-era protections, created by the Deferred Action for Childhood Arrivals program (DACA), which spared these immigrants from deportation and authorized work permits. He reiterated this pledge in February to a group of reporters in the Oval Office, saying, “we’re going to be ending that.” But in court documents filed in the U.S. District Court for the Central District of California on Tuesday, Judge William Alsup responded that Trump couldn’t fulfill a single one of the campaign promises that gave rise to the lawsuit. “The present case is a fishing expedition,” Alsup wrote. “The court will not grant a series of discovery demands aimed at generating support for a cause that rests on an assertion the court has already ruled against as a matter of law.” Alsup added that the attorneys general sought to “turn this case into a trial by ambush,” and thus, he dismissed the complaint with prejudice. “It will be highly unusual for a judge to dismiss a complaint with prejudice,” University of California, Hastings College of the Law professor Mark Stern told The Daily Beast. “But the judge clearly did not think this case had any merit.” The lawsuit was filed by the attorneys general in California, New York, Texas, the District of Columbia, Pennsylvania, and the Pueblo of Santa Fe in September. On the weekend that the suit was filed, Trump rescinded DACA protections, tweeting: “Effective immediately, @ImmigrationPolicy will end the failed Obama Administration program known as DACA that was implemented in 2012 without proper authority.” But according to Alsup, it took some cojones to sue him, pointing out that the president’s tweets were “not legally binding.” “As the president correctly noted, any individual’s right to be president is subject to no higher duty than the law.
