loss, less any necessary payments made or to be made under subsection (a)(1)(i). See In re Robert E. Stiver, 892 F.2d 951, 956 (3d Cir.1990). The statute, however, makes no reference to a net worth in establishing the loss. See id. Although his net worth is established by the terms of subsection (a)(1)(ii), the plaintiff has provided no

evidence of any sum which the government owed him at the time of his discharge or the date of his separation from service. Under the terms of subsection (a)(1)(ii), either of those dates would be the appropriate ones to consider when calculating the "unpaid service credit." Plaintiff has produced no evidence that the Navy ever owed him a

sum as a result of his discharge or separation from service, such that the "unpaid service credit" that is to be taken into account under subsection (a)(5)(A) could be a net amount owing to plaintiff for any of those dates. See Stiver, 892 F.2d at 956. Because he has offered no evidence that such an amount could be included in his calculation of

the amount of his lost wages, the plaintiff has failed to establish a prima facie case under section 2304(a)(5)(A). Plaintiff has also failed to establish a prima facie case under section 2304(a)(6), which requires a showing that the plaintiff's loss is the proximate result of the defendant's negligent or wrongful act or omission. To

establish that he was damaged by the failure of the Air Force to return him to active duty, plaintiff must prove not only that his loss of pay was proximately caused by the defendant's failure to act, but that such loss was the proximate result of the Navy's failure to extend him a REIPR. *61 See, e.g., Kent v. United States, 543 F.2d at 578. He

has offered no evidence of the amount of his lost wages on the basis of which he has established a prima facie case. See id.; see also Stiver, 892 1cdb3666d
